Drug addict social integration system in modern Russian society

Abstract. In modern Russia an understanding and solving of drug addiction problem is actual. Social integration of a human, who took the cure, the final stage of which is when a patient together along with specialists needs the help of his relatives, people, who close to him and his associates, is important. The stage of integration is directed on links with society renewal, that is why a support and a help of people, who surround him plays an important role at this time.

Introduction

In modern Russia an understanding and solving of drug addiction problem is actual. In many scientific publications individual moments of drug addiction, such as illegal drug trade, biological aspects of drug influence on a human etc., are considered. In spite of a problem actuality, in native literature an inadequate attention is paid to drug addict social integration.

Main part

Personality social integration is a process of communication between personality and social environment, a process of forming the outness of mutual expectations' coordination, requirements and personality necessities with social environment [1-3]. Drug addiction extension is partly connected with a large-scale disorganization of relationship between personality and a surrounding environment, because it can be considered as a strategy of hardship negotiation, being in the same time the reason and a consequence of social bonds' breaking. Social adaptation of a drug addict is a process of social bonds renewal between the personality and the outworld.

As many researches show, a drug addiction along with physical well-being touches psychological and social state of a human. During the curing the man acquires redeeming features, which may help him in his further life [4]. Human social integration, for those who took the drug addiction curing courses, is an important final stage of curing on which the patient along with a help of specialists needs the help of his relatives, close ones and people, surrounding him. An adaptation stage is directed on reconstruction of links between a human and society, that is why the

support of people, surrounding him, plays an important role during this period.

In spite of the significance of social role in social adaptation of a drug addict, the society is not completely ready to accept such people. The social unwillingness is reflected in many aspects, such as: entanglements in job finding, delicacy in searching the partner for family founding, significant efforts in demand of returning confidence and respect of people, who are close this person [5, 6]. All these factors may initiate not psychological only, but narcotic brake down. This is why the question of method development of social integration of drug addict human is actual in modern Russian society.

Body

For many years the inquiry of drug addict integration was paid not enough due cognizances, generally considered the questions of physical and psychological bondage of drug addict liquidation, forgetting that the human is a part of society. After the curing in residential facilities drug addict people reborn psychologically: a new reason to live, new values, ambitions appear in their life, they have a brand new glossy beginning. But together with positive transformations, ex-addict, who yesterday didn't see anything but only a regular doze and who didn't acknowledge any social links, who lived in his own world faces the problem: "And how shall I live now?" Cured from bondage person starts new life and world acknowledge, searching and cognizing new life values, new cues. But as distinct from children, to whose searching the society got used to, ex-drug addict, instead of help and support, face with problems of misunderstand and social abruption.

In native authors researches a present question is not completely highlightened. The

question of social integration of drug addict people deserves more attention, because this process is longer than drug addict rehabilitation and includes a complex of pedagogical, socio-psychological, rehabilitation methods, directed on the reunion of a human and society, improvement of life quality of a person and full implementation of him into social environment.

One of the most important problems of social drug addict integration is human return to his family, study and work. The present problem is in that a drug addict person, during the period of drug abuse turns into ruin, without emotions, feelings, ambitions, will power. At this very point ex-drug addict acknowledges, that all his prospects, dreams he changed for illusion. At the given moment the man needs a tower of strength and support of people, who close to him, who in their turn, can not at once believe in complete recovery of ill person, this way offending and repulsing a man, who is searching in new life beginning. General problems of drug addict integration system in society is carrying out the complex of psychological, pedagogical, social and practical measures, directed on advanced results of psychological and therapeutic rehabilitation stages.

The system of social adaptation of drug addict people can be divided into 4 schemes:

- Psychotherapeutic scheme, which includes positive motivation of patient forming, renewal of communication functions, believe in himself and his opportunities.
- 2. Social integration program, which includes forming the skill of having the control over his prospects and the ways of their achieving, ability of acceptation of liability for his own life renewal, motivation and help in getting and renewal of education, preparation for life in society without psychoactive substances [8, 9].
- 3. Family adaptation program can be represented in such key positions as: relatives consulting concerning their behavior with drug addict person, family and everyday life integration, work with volunteers.
- 4. Life developing program is determined by the following trends:
 - Consulting and help in the question of job placement of ex-drug addict people;
 - Family and everyday life consultation;
 - Family relationships support.

An important role in social integration of drug addict after the curing plays creation of social and state programs, inter alia. One of the remarkable examples of state program is the program, confirmed by decision of Moscow City Government from 4th of April, year 2014, #161-PP "On conducting the

experiment on providing citizens, ill with drug addiction and who passed a treatment of white plague, services on social rehabilitation with certificate usage in Moscow City". According to present decision, drug addict citizens, who passed the treatment, may receive help in social integration with certificate usage.

"Certificate" is a nonnegotiable instrument, verifying the right of his owner, who is resident in Moscow, to get in the period of experiment on social integration in organizations, participating in this experiment, services on social integration up to 180 calendar days in succession from the day of starting such services provision" [10].

According to the statistics the majority break downs of drug addict happens in the period, when they has not already learned how to use attained knowledge on practice. This is why the question of patients' social integration programs development, in order to make them react adequately on life problems, is still actual.

Being on rehabilitation, the patient is learning how to ask for the help, to fulfill obligations which he took, how to make relationships with people, who surround him, trash out mistakes, which could become the reason of break down out of centre. Gradually the patient starts to take decisions, bear responsibility for them and get more and more independence and freedom. Also the patient, being in rehabilitation centre of social integration, may in group or individually work out his relationship and hard life situations in society, which worries him, and to find out right decision in advance [11, 12].

As the practice showed, it turned out to be very effective to hire residents, who passed the whole integration course, as consultants.

Social integration program: Speaker's integration meeting

The program of social integration practices is a periodical invitation of people, who have a large period of sobriety on speaker's meetings. Speakers share their own experience of recuperation and residents get one more cathexis of hope and believe.

Traveling groups

Also according to the program of adaptation for getting new experience from people, who recuperate out of walls of centre and the experience of visiting city groups, once a week for residents of the centre there are organized trips to Omsk city once a week on groups of self-help of Alcoholics Anonymous and Narcotics Anonimys.

Free exit

In the course of a program of social integration the resident, after three months of

rehabilitation, may get a free exit, which affords him once a week to leave without escort. He learns to orient in social life himself by being in charge for his actions

Period of probation and job placement

After 6 months of rehabilitation and social adaptation, each patient can start a period of probation in order to start working as a consultant in the centre or he, being maximally prepared to social life, may leave the centre.

Conclusions

It is worth mention, that the stage of social integration in Russia is present only in certain rehabilitation centers. At the present stage the following questions are being solved: charge shaping for own behavior and healthy way of life, new behavior skills shaping in drug addict mind, family relationship reconstruction, in active social life involving [13, 14].

The aim of present stage is a work handling with drug addict and their relatives, organizing and escorting of drug addict: assistance in training, temporary accommodation provision, official documentation restoring, resume preparation, job searching.

In majority drug addict, who successfully completed rehabilitation, find their job in rehabilitation centers and fulfill functions of assistants, housemasters, social pedagogues. Also there is a practice when headquarters of rehabilitation centers through employment services help to a drug addict, who completed rehabilitation successfully, get in organizations on blue-collar jobs. Although, it's worth mention, that official statistics on drug addict job placement is not kept. There is no state patronage over drug addict, who passed rehabilitation.

The absence of consistent national system of rehabilitation, state patronage over drug addict doesn't afford to decrease level of population narcotization, and correspondingly, a scale of drug addiction, and by these means protect DUs from ruinous addiction and the whole population from DUs [15].

In aims of rehabilitation system development, the project of single social integration system of drug addict and the algorithm of cooperation development at all stages by profile ministries in cooperation with law enforcement, sentence-implementation service, non-governmental organizations is necessary.
